

Professor Maxey is very passionate about the subject matter, which stimulates interest among even those previously uninterested. Most importantly, however, she teaches with an open-minded, accepting style, which I felt was crucial given the subject matter. I myself am not a religious person, yet I never felt judged, belittled, or unequal because of it. Professor Maxey emphasized not our individual differences, but the faith journey we all experience, regardless of whether we agree with one another.

It is difficult to believe Professor Maxey is only a PhD student. She is a masterful teacher and clearly is

knowledgable in her subject matter. The course readings were extremely interesting -- I feel like she could teach a whole course on either Eve & Adam and Dignity of Difference alone. Professor Maxey is excited and engaging, her lectures are informative and interesting, class discussions are always productive. She makes somewhat dense or dry or dated material interesting and relevant. Response papers, while sometimes bothersome to do, were actually fun to write because they allowed students to engage with the readings so well. Professor Maxey engaged all of us in productive conversation, and she accomplished her goal of making us all consider things from nuanced perspectives while situating our own perspectives.

The course made somewhat mundane topics very interesting and exciting. Also, I enjoyed bringing in the modern aspects of theology and society that are oftentimes ignored in courses like this. It made it more real to our everyday lives.

How could the instructor improve the course?

Comment

By decreasing the work load just slightly, sometimes it was overwhelming and I rushed through it.

The readings were always really long. Sometimes we would spend the whole class talking about 2 pages when the assigned reading was 30 pages. I think that narrowing down readings for discussion, but then suggesting to students that if they'd like to read pages x-y for their benefit, that would be much better in focusing discussions and lightening the heavy workload.

Some of the reading could have been omitted

The course is very heavy for a core. The reading responses can be overwhelming at times. I would say they need to be decreased by five or more.

The course was really well structured with very fair amounts of work for a core class. I know a lot of people said that there was too much work for a core class, but that just seems to be the general impression I get about most core classes at BC. I think that discussion days were more valued than lecture days. The topics are really engaging and it gets really boring to be lectured about the topics when we weren't going to be tested on them in the end.

I think it would be helpful to have less busy work, such as our almost daily reading responses, and instead add more papers or objective tests in order for the students to analyze and discuss the material. Eve and Adam

I liked Eve & Adam, Hill Fletcher, and Dignity of Difference

I think Eve and Adam was somewhat confusing but actually provided a lot of good insight. I thought Fletcher was very interesting just because it seemed very relevant to things today

The essay chapters don't mean as much to me as the readings, but I felt like Dignity of Difference was a great piece that was extraordinarily significant for our subject.

I think the structure of the course was great and that the books really elevated discussion. For the Ethics section I found Dorff to be helpful but Cahill not so much. The Dignity of Difference really stimulated the most class discussion and interest, it was an excellent choice.

I found them all helpful and would recommend them being assigned again.

I thought that all the readings were very pertinent to the information learned in class. A lot of the readings from Eve & Adam were overkill - we read so much of that book and discussed one or two things from each reading. It was a lot of work at the beginning of the semester, so refining these readings would benefit the class overall, I think.

I loved the Eve and Adam anthology, Dignity of Difference, and Fletcher's essay.

I think Hill Fletcher was helpful, as well as Cahill and Dorff for the bioethics project.

Eve and Adam anthology was awesome! It had so many great interpretations and sources. Everyone found something they could relate to.

The essays by Keenan were interesting.

I thought the Dorff Cahill book was to complex for our class. I found it hard to follow her reading. My favorite book was The Dignity of Difference, it was relevant to the class and modern day. It also wasn't overly religious. Instead, it really looked at the world and policy.

I think all the reading materials were helpful and thought-provoking. I especially enjoyed The Dignity of Difference and similar texts; I always really liked our discussions on interreligious dialogue and "being able to find God's image" in someone other than ourselves.

The essays by Keenan, and Sack's Dignity of difference were really helpful and entertaining texts to read.

I loved The Dignity of Difference

I wasn't very fond of the Eve and Adam anthology, or rather how much time we spent on it. I enjoyed all the other readings.

I thoroughly enjoyed each of the assigned readings--they attacked global topics, but related them to the main religious themes of the course. I would definitely assign Hill Fletcher and Jonathan Sacks for future classes.

The Adam and Eve anthology was very interesting. Actually I enjoyed most of the readings, but Cahill was a bit hard to follow (maybe it was just the section we read). The Dignity of Difference was probably my favorite, and the most helpful for looking at our world as it is.

I particularly enjoyed reading primary sources in the Eve and Adam anthology we read. It was also interesting to read some of the major theologians in the field of interreligious dialogue. I would recommend that the readings be assigned again.

All of them were great and easy readings.

The Eve and Adam anthology was a bit repetitive - hard to grasp the many interpretations of biblical text. Dignity of Difference was easy/interesting. The start of Cahill's work was a bit confusing, whereas Dorff was easy to understand/useful for assignments.

Compared to semester 1, the reading this semester was much more manageable and engaging. I particularly loved Eve and Adam, The Dignity of Difference, Cahill, and Hill Fletcher. I would recommend that those 4 definitely

be assigned again.

Final Exam was a great idea

I thought the reading responses kept us accountable and on track and really helped me do the readings on time. The group ethics presentation was really fun and interesting and a good way to get to know the other people in the class. I LOVED the final. It was so interesting and a great way to engage in a dialogue that incorporated the things we learned throughout the course with our personal stories.

I think the reading responses were somewhat annoying, but at the same time I think they definitely allowed me to process the information and formulate some sort of idea on what was being read. I thought the final exam was awesome. It was really cool to hear hear other people's stories and it was also kind of fun making my own.

I really enjoyed the ethics project at the group and individual level. It really allowed us to investigate a topic we were particularly interested at both the Christian and Jewish level. I thought there was a lot of reading responses but it was good motivation for doing the reading and you gave good feebdack.

I preferred the reflection reading responses (what did you learn, what surprised you, what questions do you have?) to the ones that directed a specific question. The individual project went much more smoothly than I ever would have imagined with that many people in one group and I think it definitely helped that we didn't have to write a paper for it - when talking about ethics it is a lot more fluid to state your opinions rather then try to write them out. The final exam is the perfect way to end the year - I think it would have been disappointing to have to take a traditional written exam. I really like that I can reflect on who I am and how I've grown from this course.

I thought you covered a broad range of types of assignments which was great!

The reading responses should be cut down. Maybe cut 5.

The comparative essay was a lot of work, you had to find research. However, I really enjoyed finding readings about my topic because I was able to develop my own paper topic, allowing me to impose the direction I wanted to go in.

The group ethics presentation was awesome, but I would choose one or the other. I felt like I was doing a ton of repetition in the individual ethic project. One is necessary, not both.

Reading responses were always really helpful. My favorite assignment was the group ethics project. I also really like what our final is composed of; I think it will be a good way to talk about what we've learned about ourselves throughout the year.

There were a lot of people in the group projects which made a few people in our group feel like they could slack off, maybe smaller groups would be easier to work with.

I thought there were a lot of reading responses, especially with Adam and Eve. However, the other responses were a lot more manageable. The comparative essay and ethics projects were manageable and interesting as well. I really like the final exam, especially as a graduating senior. It was a great way to look back on one's life experiences and where I'm headed after graduation.

I thought that all of the group projects, including the final presentation, were extremely useful. The comparative essay on Genesis commentaries was definitely the most difficult assignment, but it allowed me to think more critically.

The reading responses were helpful because they forced us to not only do the readings, but to also be thoughtful about them. The paper was fine, Maxey gave us plenty of help especially with resources. The group project wasn't necessarily difficult, but it was hard to coordinate such a large group. Group projects are always really hard,

especially around midterms, because everyone's schedules are so different. The individual project was good, and the final exam was a good way to apply what we've learned to my own identity. I think all the assignments worked well with the structure of the course and the material.

I enjoyed the group presentations, the individual ethics progect, and the comparative essay. I would subtract some of the reading responses because they were often a burden to complete for every class, causing me to rush through them instead of spending more time on close reading of the text.

I enjoyed all of this semester's assignments. I experienced a lot of growth as a student particularly through the comparative Genesis essay, which was a new experience for me. I fully admit that the sheer size of the ethics groups caused each of us to put less effort in than if our groups were smaller. Nonetheless, I enjoyed the assignment and learned a lot from it.

Responses were actually fun, though they were occasionally a burden with other classes and when there were multiple due for 6 class sessions in a row. The comparative essay was challenging but interesting to write, allowing us to pursue topics from E&A. The individual ethics project was great -- the format was new to me and it wasn't too challenging. The group project was interesting and teaching the class was a great change of pace and great speaking practice, but working with 7 or 8 others was difficult. The final project is unlike anything I've heard -- and it is testament to Professor Maxey's classroom innovation.

The ethical discussions of this semester were definitely ones that we could take outside the classroom and apply to our everyday lives. I liked this aspect because we could put our opinions in conversation with those put forward by the two traditions we were studying.

A lot of information, specifically bioethics, morality, existence of God, were slightly covered in my philosophy class, but overall all of the topics pertain to everyday life.

I think the class provided a nice overview of how faith can be integrated in many sectors of life.
